• Two expert networking technicians to be engaged from an authorized third-party service provider for technical assistance and on-ground implementation.

#### Roles and Responsibilities:

#### 1. Management of Campus Networking Infrastructure:

- Oversee the operation and maintenance of the entire campus networking system, including the college academic buildings, hostels, and residential quarters.
- Ensure the availability of a stable, secure, and high-speed internet connection across all zones of the campus.
- Liaise with the third-party technicians for routine checks, troubleshooting, and upgradation of network components such as routers, switches, access points, and cabling.

## 2. Issue Resolution and Technical Support:

- Act as the coordinating body to resolve all network-related issues reported by faculty, staff, and students.
- Maintain a log of complaints received, actions taken, and downtime (if any) for internal review and future planning.

## 3. Supervision of CCTV Surveillance Systems:

- Ensure proper functioning of CCTV systems installed across classrooms, administrative offices, hostels, gates, corridors, and other strategic locations.
- Coordinate routine inspection and servicing of CCTV cameras, DVR/NVR systems, and storage units with the support of technical staff.
- Facilitate retrieval of CCTV footage when required for security or administrative purposes.

## 4. Coordination with Third-party Service Provider:

- Supervise and coordinate the work of hired networking technicians for dayto-day maintenance and emergency interventions.
- Ensure that service-level agreements (SLAs) with the third-party agency are adhered to.

## 5. Upgradation and Infrastructure Development:

- Periodically assess the performance of networking and CCTV systems and propose upgradations or expansions based on technological advancements and institutional needs.
- Preparing technical specifications and budget estimates for procurement of new equipment.

#### 6. Installation and Maintenance of Bio-Metric Attendance System:

- Prepare detailed technical specifications and budget estimates for the procurement of new bio-metric equipment, as and when required by the College Authority.
- Periodically assess and report the performance and functionality of the Bio-Metric Attendance System to ensure optimal operation.

#### 7. Reporting and Documentation:

- Submit periodic reports to the Director's Office on the status of the networking and CCTV infrastructure, including issues resolved and future recommendations.
- Maintain detailed documentation of equipment inventories, servicing records, and system diagrams.

Dr. Apurba Roy (for networking-related materials/documents) and Dr. Arunava Bhattacharyya (for CCTV-related materials/documents) are requested to hand over materials, relevant files and documentation to Mr. Alok Maiti at the earliest convenience.
